A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING WESLEY HOUSE FAMILY SERVICES, INC. TO CONDUCT A FAMILY FRIENDLY HOLIDAY VILLAGE "PRE-PARTY" AND THE ANNUAL BELIGHTED BIKE RIDE ON FRIDAY, DECEMBER 2, 2022, STARTING AT THE KEY WEST COFFEE BUTLER AMPHITHEATER AT 4:00 P.M TO 10:00 P.M; THE BELIGHTED BIKE RIDE WILL START TRAVELING TOWARDS WHITEHEAD STREET TO FRONT STREET, TAKING A RIGHT ON DUVAL STREET, RIDING THE LENGTH OF DUVAL STREET, RETURNING BACK TO THE AMPHITHEATER; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The Wesley House Family Services, Inc. wishes to conduct their annual Belighted Bike Ride and Holiday Village as a fundraiser for the non-profit.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida.

**SECTION 1.** That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law"

**SECTION 2.** "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and

"to go" packages for food or products sold on any property leased from the City"

**SECTION 3.** That the Wesley House Family Services, Inc. is hereby granted permission to conduct their annual Holiday Village & Belighted Bike Ride on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

**SECTION 4.** That the Wesley House Family Services, Inc. is hereby granted permission for the use of the Coffee Butler Amphitheater, and the closure of certain streets on the date and during the hours stated above for the Belighted Bike Ride.

**SECTION 5.** That the applicant acknowledges this authorization may be revoked by the Commission or the City Manager, due to exigent circumstances such as the resurgence of COVID-19 in the community.

**SECTION 8.** That Wesley House Family Services, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

**SECTION 9.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
