WHEREAS, the City of Key West Comprehensive Plan was developed in response to the requirements of the Local Government Comprehensive Planning and Land Development Regulations Act (Chapter 162, Part II, Florida Statutes); and

WHEREAS, on August 26, 2022, City leadership met to discuss updates to the City's Strategic Agenda and formed a small working group to update the City's Mission Statement and Core Value located within the Introduction of the City's Comprehensive Plan under the City's current Vision Statement; and

WHEREAS, the working group met three times to update the Mission Statement and met with all Directors and Managers to finalize the recommended change of the Mission Statement, and concluded that a Vision statement was no longer needed; and

WHEREAS, the working group developed additional Core Values which were subsequently vetted through Directors and Managers at a staff

Section 3. This resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Board.

Section 4. This resolution is subject to appeal periods as provided by the City of Key West Code of Ordinances (including the Land Development Regulations). After the City appeal period has expired, this permit or development order will be rendered to the Florida Department of Economic Opportunity. Pursuant to Chapter 73C-33, F.A.C., this permit or development order is not effective for forty-five (45) days after it has been properly rendered to the DEO with all exhibits and applications attached to or incorporated by reference in this approval; that within the forty-five (45) day review period, the DEO can appeal the permit or development order to the Florida Land and Water Adjudicatory Commission; and that such as appeal stays the effectiveness of the permit until the appeal is resolved by agreement or order.
