A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE ANNUAL KELLY MCGILLIS CLASSIC INTERNATIONAL WOMEN'S FLAG FOOTBALL CHAMPIONSHIP AND WORLD CHALLENGE GAMES TO HOLD A PARADE ON THURSDAY, JANUARY 26, 2023 FROM 6:00 P.M. TO 7:00 P.M. THE TEAMS WILL MARCH FROM LANDS END MARINA - 231 MARGARET STREET TO CAROLINE STREET, TO GREENE STREET, TO FRONT STREET, RIGHT ON GREENE STREET, TO FRONT STREET, DOWN DUVAL STREET AND ENDING AT UNITED AND DUVAL STREETS; AUTHORIZING THE CLOSURE OF SAID STREETS FOR THE PARADE; AUTHORIZING THE KEY WEST WOMEN'S FLAG FOOTBALL LEAGUE THE USE OF DEWITT'S ROBERTS FIELDS AND POINCIANA FIELDS FOR THEIR TOURNAMENT; PROVIDING FOR AN EFFECTIVE DATE

BE IT RESOLVED by the City Commission of the City of Key West, Florida, as follows:

WHEREAS the Annual Kelly McGillis Classic International Women's Flag Football Championship and World Challenge Games wishes to conduct their annual event January 26, 2023.

SECTION 1. That in Resolution 19-174, the City Commission directed the city Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law"

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor

therefore, commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and “to go” packages for food or products sold on any property leased from the City”

SECTION 3. That Annual Kelly McGillis International Woman’s Flag Football Championship World Challenge Game is hereby granted permission to hold a parade starting on Front Street to Duval Street and ending on United Street from 6:00 p.m. to 7:00 p.m. on Thursday, January 26, 2023, and that they are hereby granted permission to use Dewitt Roberts Field and the Poinciana Fields for their Flag Football Tournaments.

SECTION 4. That the Annual Kelly McGillis International Women’s Flag Football Championship and World Challenge Game will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

SECTION 5. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officers and Clerk of the Commission.
