A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF ONE (1) CATERPILLAR TH255C TELESCOPIC TOOL CARRIER WITH RELATED ACCESSORIES (\$105,595.00) AND ONE (1) JLG 660SJ TELESCOPIC BOOM LIFT WITH RELATED ACCESSORIES (\$144,567) IN A TOTAL AMOUNT NOT TO EXCEED \$250,162.00 FROM KELLY TRACTOR CO., THROUGH PIGGYBACKING ON THE FLORIDA SHERIFF'S ASSOCIATION AND FLORIDA ASSOCIATION OF COUNTIES BID NO. FSA20-EQU18.0, HEAVY EQUIPMENT CONTRACT, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES FOR USE BY THE KEY WEST COMMUNITY SERVICES DEPARTMENT; AUTHORIZING NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, this purchase will be made under the Florida Sheriffs Association and Florida Association of Counties Bid No. FSA20-EQU18.0 Contract, pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of one (1) Caterpillar TH255C Telescopic Tool Carrier (fork lift) and related accessories (\$105,595.00), and one (1) JLG 660SJ Telescopic Boom Lift with

related accessories (\$144,567.00), as described in the attached proposals of Kelly Tractor Co., pursuant to section 2-797(3) of the Code of Ordinances, under the Florida Sheriff's Association and Florida Association of Counties FSA20-EQU18.0 Heavy Equipment Contract, in a total amount not to exceed \$250,162.00, is hereby authorized for purchase and use by the Community Services Department.

Section 2: That funds for the purchase of this equipment are budgeted under Infrastructure Surtax/Truman Waterfront /Machinery and Equipment Account 101-4303-543-6400 (\$215,000). A transfer of \$35,162.00 is hereby authorized from Infrastructure Operating Reserves account 101-1900-519-9803, to Truman Waterfront Machinery and Equipment account 101-4303-543-6400 to cover the balance of the equipment cost. Any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
