A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF ONE (1) WACKER NEUSON G70 58kw GENERATOR WITH RELATED ACCESSORIES IN A TOTAL AMOUNT NOT TO EXCEED \$63,685.00 FROM KELLY TRACTOR CO., THROUGH PIGGYBACKING ON THE FLORIDA SHERIFF'S ASSOCIATION AND FLORIDA ASSOCIATION OF COUNTIES BID NO. FSA20-EQU18.0, HEAVY EQUIPMENT CONTRACT, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES FOR USE AT THE FLEET SERVICES BUILDING; AUTHORIZING NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, this purchase will be made under the Florida Sheriffs Association and Florida Association of Counties Bid No. FSA20-EQU18.0 Contract, pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of one (1) Wacker Neuson G70 Generator and related accessories as described in the attached proposal of Kelly Tractor Co., pursuant to section 2-797(3) of the Code of Ordinances, under the Florida Sheriff's Association and Florida Association of Counties FSA20-EQU18.0 Heavy Equipment Contract, in a total amount not to exceed \$63,685.00, is hereby authorized for purchase and use at the Fleet Services Building.

Section 2: That funds for the purchase of this equipment are budgeted under General Fund/Fleet/Machinery and Equipment Account 001-1904-519-6400 (\$55,000). A transfer of \$8,685.00 is hereby authorized from General Fund Operating Reserves account 001-1900-519-9803, to account 001-1904-519-6400 to cover the balance of the equipment cost. Any related and necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
