A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "TEMPORARY USE AGREEMENT ADDENDUM -- BOT #440360555" ("SECOND ADDENDUM") BETWEEN THE CITY OF KEY WEST ("CITY") AND THE BOARD OF TRUSTEES OF THE INTERNAL IMPROVEMENT TRUST FUND OF THE STATE OF FLORIDA ("BOARD") FOR THE KEY WEST BAR PILOT VESSEL MOORING AREA WATERWARD OF 700 FRONT STREET; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Key West has a Temporary Use Agreement with the Board of Trustees of the Internal Trust for certain sovereignty submerged lands located waterward of 700 Front Street, as depicted on Exhibit A attached hereto; and

WHEREAS, in Resolution 22-221, the City Commission approved a First Addendum to the Temporary Use Permit, to provide time to complete application and negotiation for a long-term lease; and

WHEREAS, the area is necessary for use as a Bar Pilot Vessel Mooring Area, and the City is in process of obtaining approval of a new submerged lands lease for the location; and

WHEREAS, City staff recommends approval of the attached Temporary Use Agreement Addendum (Second Addendum), to further extend the period of the Temporary Agreement through August 18, 2023, or the date of execution of a sovereignty submerged lands lease between the Board and the City, whichever occurs first; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached "Temporary Use Agreement Addendum -- BOT # 440360555" (Site No. 406657/Project No. 398121) (Second Addendum) for the Bar Pilots Vessel Mooring area is hereby approved.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
