A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF TWENTY-TWO (22) 2023 FORD POLICE INTERCEPTOR SUV VEHICLES AND TWO (2) 2023 FORD F-150 RESPONDER K-9 TRUCKS AT A TOTAL AMOUNT NOT TO EXCEED \$1,442,342.92 FROM BARTOW FORD, THROUGH PIGGYBACKING ON THE CHARLOTTE COUNTY PURCHASING CONTRACT NO. 2021000541, PURSUANT TO SECTION 2-797(3)(a)(b)(c) (PURCHASES UNDER **GOVERNMENT** CONTRACT) AND 2-797(4)(b) (BEST INTERESTS) OF THE CODE OF ORDINANCES FOR USE BY THE KEY WEST POLICE DEPARTMENT; AUTHORIZING ANY NECESSARY TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, this purchase will be made under the Charlotte County Government Bid No. 2021000541, pursuant to section 2-797(3)(a)(b)(c) and 2-797(4)b (best interests) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of twenty-two (22) 2023 Ford Police Interceptor SUV Vehicles and two (2) 2023 Ford F-150 Police Responder K-9 Trucks, as described in the attached proposal of

Bartow Ford, pursuant to section 2-797(3)(a)(b)(c), and 2-797(4)(b) of the Code of Ordinances, under the Charlotte County Government Purchasing Contract 2021000541, in an amount not to exceed \$1,442,342.92, is hereby authorized for use by the Key West Police Department.

Section 2: That funds for this purchase are budgeted in FY 23 under account number 101-2101-521-6400 in the amount of up to \$1,395,322.00. A necessary budget transfer from Infrastructure Surtax Fund Operating Reserve account 101-1900-519-980 in the amount of up to \$47,100.00 is hereby authorized, along with related budget adjustments and transfers as necessary.

Section 3: That the City Manager or designee is authorized to execute any necessary documents upon advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
