

RESOLUTION NO. 20-095

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF CHARLEY TOPPINO AND SONS, INC. FOR PAVEMENT MARKINGS, STRIPING & ROADWAY SIGNAGE ON A TASK ORDER BASIS, AT UNIT PRICES IDENTIFIED IN THE BID, IN ACCORDANCE WITH THE TERMS SPECIFIED IN ITB 20-007; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS IN SUBSTANTIAL CONFORMANCE WITH THE CONTRACT DOCUMENTS CONTAINED IN THE BID PACKAGE AND UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, one bid was opened in response to ITB #20-007, for Pavement Marking, Striping and Roadway Signage, and the bid was determined to be responsive; and

WHEREAS, upon staff review, including cost comparisons with other government agencies, it was recommended that the contract be awarded to the sole bidder, Charley Toppino and Sons, Inc.; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of Charley Toppino and Sons, Inc. for Pavement Markings, Striping and Roadway Signage, in accordance with the terms specified in ITB #20-007 is awarded, on a task order basis, at the unit prices identified in the bid.

Section 2: That the City Manager is authorized to execute a contract in substantial conformance with the contract documents contained within the bid package on behalf of the City of Key West, upon the advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
