A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PURCHASE APPROVED BY THE CITY MANAGER IN EXCESS OF \$20,000 AS ALLOWED UNDER SECTION 2-797(2) OF CITY'S CODE OF ORDINANCES, FOR THE PROCUREMENT FROM ATKINS AMERICA OF ADDITIONAL GROUNDWATER INVESTIGATION AND CONTAMINATION POSSIBLE ABANDONMENT MONITORING WELLS AT OF ANGELA STREET; AUTHORIZING NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in 2013 the City executed a task order to perform a site assessment for groundwater contamination and possible abandonment of monitoring wells at 525 Angela Street; and

WHEREAS, the monitoring contemplated in the First Task Order was completed in December 2013, and documented in the "Former City Hall SARA Limited Contamination Assessment Report," dated February 12, 2014; and

WHEREAS, based on the report, the Florida Department of Environmental Protection has recommended the installation of up to three (3) new monitoring wells, and additional groundwater sampling to further define the extent of contamination, and determine if monitoring well abandonment is indicated; and

WHEREAS, the City Manager acted without delay, utilizing emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to procure additional monitoring services.

and installation of up to three (3) new monitoring wells, at an additional cost of up \$16,785.00; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSON OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: The City Commission, in accordance with Section 2-797(2) of the City of Key West Code of Ordinances, hereby ratifies the City Manager's emergency authorization for the procurement in the total amount of \$31,630.00 (\$14,755 approved in first task order, \$16,875.00 additional funding approved pursuant to this resolution) from Atkins North America, for groundwater monitoring and monitoring wells at 525 Angela Street.

Section 2: That a necessary budget transfer from account 001-1900-519-98-01 to 001-1906-519-46-00 is authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by
