A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING A PURCHASING EXCEPTION PURSUANT TO SECTION 2-797 OF THE CODE OF ORDINANCES, TO ALLOW THE CHANGE ORDER EXECUTION OF Α CONSTRUCTION GROUP, INC. IN AN AMOUNT NOT TO EXCEED \$47,706.00 FOR FLOORING; RATIFYING A PURCHASING EXCEPTION TO ALLOW THE EXECUTION OF A CONTRACT TO CONSOLIDATED ENVIRONMENTAL ENGINEERING IN AN AMOUNT NOT TO \$78,400.00 FOR MOLD REMEDIATION; AUTHORIZING BUDGET TRANSFERS TO PROJECT PD POLICE STATION WINDOWS REPLACEMENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$20,000.00; and

WHEREAS, in Resolution No. 13-292, the City Commission approved a contract for window replacement by ELCI in the total amount of \$287,902.00; and

WHEREAS, during the process of replacing windows, it was determined that there was mold on building walls, and in carpeting in several areas of the building, which requires remediation; and

WHEREAS, City and KWPD staff established a scope of work and requested ELCI to provide costs to address flooring needs concurrent with the window replacement work; and

WHEREAS, separate quotes were obtained for mold remediation, with Consolidated Environmental Engineering submitting the lowest responsive bid; and

WHEREAS, completion of this work through a purchasing exception will resolve a clear and present threat to public health, property and safety, pursuant to section 2-797(2) of the Code of Ordinances.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the expenditure of funds not to exceed \$47,706.00 to ELCI for flooring removal and replacement, as described in Change Order #1, is hereby ratified, in accordance with Key West City Code of Ordinances section 2-797(4)(b), and the City Manager is authorized to execute a change order, upon advice and consent of the City Attorney.

Section 2: That the expenditure of funds in excess of \$20,000, but not to exceed \$78,400.00, to Consolidated Environmental Engineering for mold remediation is hereby ratified, and the City Manager is authorized to execute a contract, upon advice and consent of the City Attorney.

Section 3: That budget transfers necessary for this project are authorized from budget line 001-1906-519-4600 to cost center PD 1302 = 001-1909-519-4600 for Police Station Windows Replacement:

Commission.
