Tree Species: Gumbo Limbo (Bursera simaruba)



Diameter: 13.6" Location: 50% (rots causing foundation issues) Species: 100% (on protected tree list) Condition: 60% (fair) Total Average Value = 70 % Value x Diameter = **9.5 replacement caliper inches**







Recommendations: Recommend approval of the removal of (1) Gumbo Limbo tree located at 54 Merganser Lane, to be replaced with 9.5 caliper inches of FL#1 native dicot or fruit tree.


