An application was received for the removal of **(1) Pink Tabebuia tree**. A site inspection was done on March 3, 2014 and documented the following:

Tree Species: Pink Tabebuia (*Tabebuia heterophylla*)



Diameter: $38'' - 24'' = 14''$ dsh

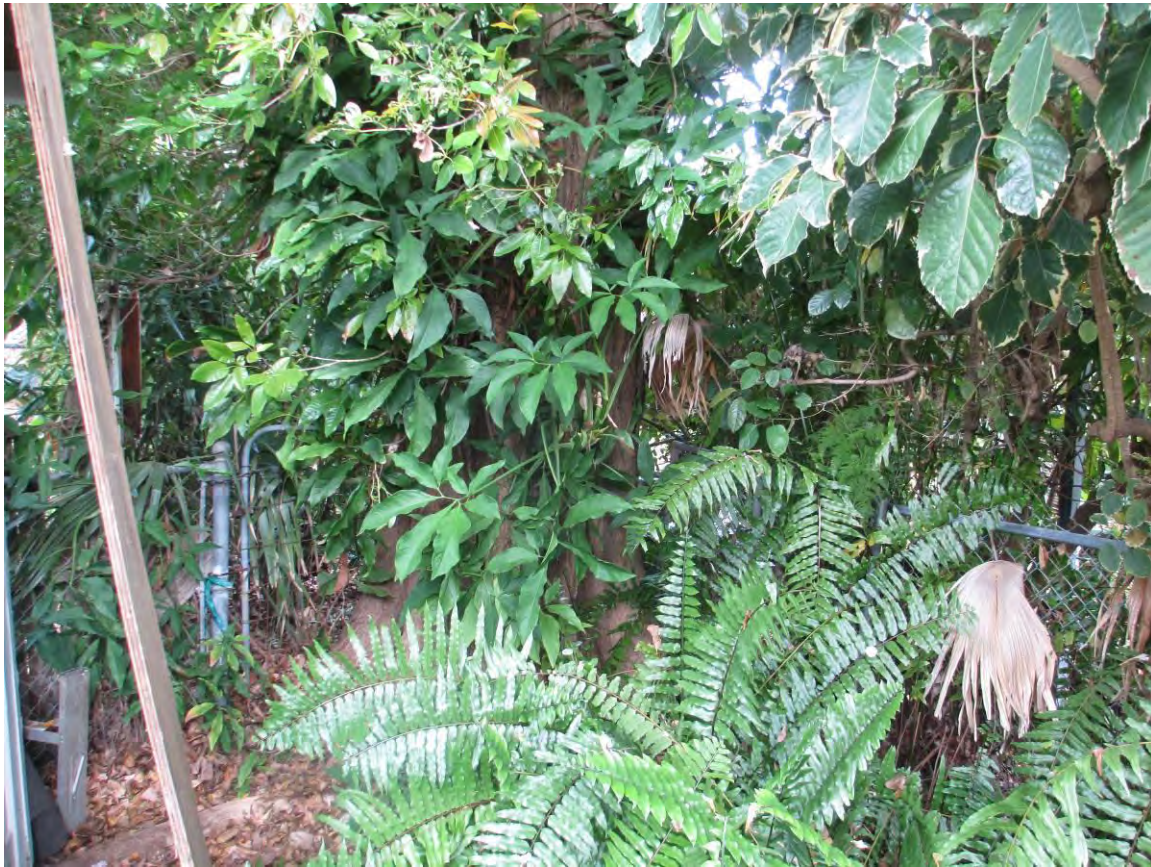
Location: 60% (backyard tree located at property line corner)

Species: 0% (on not protected tree list)

Condition: 80% (good—large tree)

Total Average Value = 46%

Value x Diameter = **6 replacement caliper inches**





Recommendations: Recommend approval of the removal of (1) Pink Tabebuia tree located at 733 Unites Street, to be replaced with 6 caliper inches of FL#1 native dicot or fruit tree.

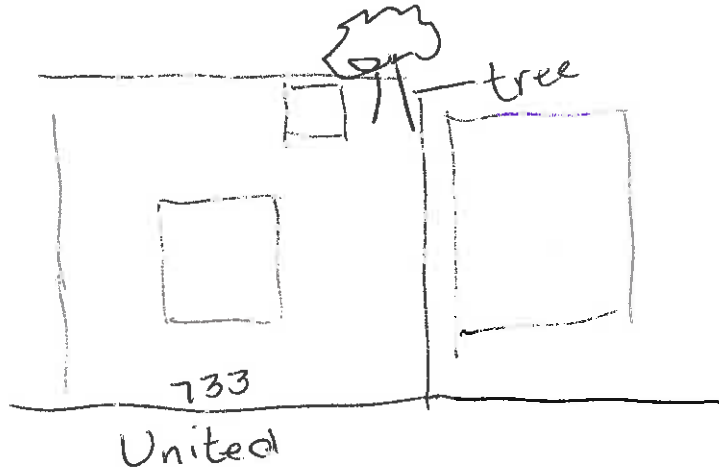
