

## Sustainability Update – 1/10/13

### **A) Climate Marketing: Preserve Island Life**

The Preserve Island Life program is officially started! We got some [great press from the Citizen](#) and will be sending out the resulting Press Release video to a wider media audience shortly.

### **B) January is Green Resolutions Month**

### **C) February is Water Quality Month**

An item I forgot during my last report was the Florida DEP award that The City of Key West and OMI received for outstanding wastewater treatment plant operation, maintenance and compliance with state requirements. Key West's Richard A. Heyman Environmental Pollution Control Facility is one of just seven statewide to be recognized with this award.



#### **D) March is Transportation Month**

Looking ahead, I've been plotting with multiple partners to make a big splash in March. We hope to address:

#### **G) Utility Tracking Project**

Two timely updates to the wrangling of the water and electric use include the help of new intern Diane Leightman who is helping me build our access-based database (which helps with FEMA and leaseholder management too) and the moving forward of UtilityTrac, a software that will help us get our bills in line and flag problems for us to fix. Stay tuned!

#### **H) Green Building**

- The US Green Building Council South Florida branch is providing a free lunch education session for all City employees interested in learning more about green certification. It is scheduled for Thursday, January 10<sup>th</sup> at noon. According to Florida Statute, all public buildings must be built to meet green certification standards. While we have already given suggestions for LEED Gold for the upcoming Public Transportation Building, smaller projects like the Tennis Pro shop in Bayview and the Sextons House are also going to be greened up soon.

Initial discussions with the Truman Waterfront Master Plan consultants design team highlighted water capture, no irrigation landscaping, community gardens and other green design features. I will be meeting with Anthony Sarno with mbi-k2m on concrete plans soon.

- US Green Building Council - Keys Branch: The LEED Green Associates accreditation prep training course: Core Concepts and Strategies (a requirement for the exam) will be on Friday, January 11<sup>th</sup>. #### **J) Grants**

- **Bahama Village Community Redevelopment Agency:** **WON!!!** The [proposal for a community garden](#) presentation was heard by BVRAC on January 3<sup>rd</sup> and awarded \$20,000. Stay tuned for more details.
- **Solid Waste Management Grant:** Although much initial work was done on this grant with our partners from the County and FKCC and UF/County Extension Service, it was determined that our needs would not score high enough to be competitive in this grant, which prioritized rural, high poverty areas. The good news is that the work that was accomplished can be used for other grant opportunities in the future.
- **National Fish and Wildlife Foundation [Environmental Solutions Grant](#):** A full proposal was not requested, but we recently received word that the group was awarded \$4B from the BP settlement, so we expect to have another chance in the future.
- The **HUD-[Southeast Florida Regional Partnership](#)** – No change

- **Florida Dept of Agriculture and Consumer Services: \$5K [Community Gardens Grant](#). **WON!!!**** by Sigsbee Charter school.
- **Audubon/Toyota [Together Green Innovation Grant](#): \$28,500: [Climate Adaptation Planting](#) **WON!!!**** We are working on site plans for the Cistern at Indigenous Park. The Mid Term report was turned in and Florida Keys Audubon has received its second payout for the project.
- **ClimateWise Partnership: [The Geos Institute](#)**, a non profit that helps regions predict, reduce and prepare for a changing climate, partnered with the County and Key West to put in an application to FEMA's Community Resilience Innovation Challenge. Dubbed [ClimateWise](#), their program involves public workshops and risk assessments to identify vulnerabilities and prioritize adaptation strategies.
- **[Dept of Energy – South Florida Regional Planning Council](#): \$500,000:** This project prepares South Florida region's communities for successful and accelerated deployment of plug-in electric vehicles and infrastructure. No update.
- **The Funders Network [Local Sustainability Matching Fund](#):** Expected to be announced in late fall.
