A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE KEY WEST GIRLS SOFTBALL TRAVEL TEAMS 8U, 10U & 12U TO CONDUCT A CO-ED SOFTBALL AND CORNHOLE TOURNAMENT FUNDRAISER AT THE WICKERS FIELD COMPLEX ON SATURDAY, MAY 3, 2014 FROM 9:00 A.M. TO 11:00 P.M. PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE OFFICE OF THE CITY MANAGER; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 9:00 A.M. TO 11:00 P.M. ON SATURDAY, MAY 3, 2014; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES ON THE DATE AND DURING THE HOURS STATED ABOVE; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The Key West Girls Travel Teams 8U, 10U, & 12U wishes to conduct a fundraiser for their Softball Travel Team on the date and during the hours stated above to benefit a Key West Girls Softball Travel Teams;

NOW THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida:

SECTION 1. That the Key West Girls Softball Travel Teams 8U, 10U and 12 U are hereby granted permission to conduct a Fundraiser on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and the organization meet the terms and conditions set forth by the City of Key West and that 100% of the money collected shall be donated to the Key West Girls Softball Travel Teams.

SECTION 2. That pursuant to Section 18-86 of the Key West Code of Ordinances, the Key West Girls Softball Travel Team is hereby granted permission to allow the sale and consumption of alcoholic beverages.

SECTION 3. The Key West Girls Softball Travel Teams are hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. The Key West Girls Softball Travel Teams will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrel will be used and that they will be placed side by side.

SECTION 5. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
