A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A PURCHASING EXCEPTION PURSUANT TO SECTION 2-797 OF THE CODE OF ORDINANCES, TO ALLOW CUMULATIVE EXPENDITURES DURING FY 13-14 TO MUNICIPAL CODE CORPORATION FOR CODE OF ORDINANCE SUPPLEMENTS IN A TOTAL AMOUNT NOT TO EXCEED \$28,745.80; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$20,000.00; and

WHEREAS, Municode is the sole provider of the City's ordinance supplements, and the Legistar electronic agenda system, and in the FY 13-14 budget a total of \$7,000 was budgeted for ordinance supplements and \$13,746 for Legistar maintenance (under separate purchase orders); and

WHEREAS, during FY 13-14, the volume and cost of code supplements has exceeded the budgeted \$7,000.00 and an increase of \$8,000.00 is necessary from City Manager contingency funds;

WHEREAS, an up-to-date Code of Ordinances is an essential tool to protect and enhance the health, safety and welfare of the citizens and government of the City of Key West; and

WHEREAS, the City Manager finds that pursuant to section 2-797(4), it is in the best interest of the City to authorize an expenditure in excess of \$20,000.00 for supplements and

electronic agenda support provided by Municipal Code Corporation.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the expenditure of funds in excess of \$20,000.00, but not to exceed \$28,745.80, to Municipal Code Corporation is hereby authorized in accordance with Key West City Code of Ordinances section 2-797(4)(b)

Section 2: That blanket purchase order No. 75683 is authorized to be increased from \$7,000.00 to \$15,000.00, and a necessary budget transfer in the amount of \$8,000.00 from the City Manager's Contingency fund is authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
