An application was received for the removal **of (1) Cecropia tree**. A site inspection was done on June 13, 2014 and documented the following:

Tree Species: Cecropia tree (Cecropia sp.)



Diameter: 9.5

Location: 50% (too close to building, in private yard/garden area) Species: 50% (not on protected or not protected tree list) Condition: 50% (fair, trunk has a lean. base of tree and roots exposed) Total Average Value = 50%

Value x Diameter = **4.8 replacement caliper inches**



Regulated tree to be removed









Recommendations: Recommend approval of the removal of (1) Cecropia tree located at 618 Freeschool Lane, to be replaced with 4.8 caliper inches of FL#1 native dicot or fruit tree.


