SECTION 1. That permission is hereby granted to conduct the TRIKW, LLC Triathlon on the date and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

SECTION 2. That TRIKW, LLC is hereby granted permission for the closure of certain streets throughout the city for the Triathlon on the date and during the hours stated above.

SECTION 3. That TRIKW, LLC will be coordinating with the agencies outside of the City of Key West jurisdiction for their part in the race.

SECTION 4. That the TRIKW, LLC is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 5. That the Event organizers will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.
