A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZATION _____ THE USE OF THE SOUTHERNMOST BEACH CAFE AT 1405 DUVAL STREET AND ADJACENT CITY PROPERTY FOR A CELEBRATION OF LIFE IN HONOR OF PETER ANDERSON ON SATURDAY, AUGUST 2, 2014 STARTING AT 3:30 P.M. WITH A GATHERING AT MALLORY SQUARE AND A PARADE TO FRONT STREET AND DOWN DUVAL TO THE SOUTHERNMOST BEACH CAFÉ; AUTHORIZING THE SALE OF CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE BARRICADED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, _____ has requested the use of the Southernmost Beach Café and adjacent City property starting at 3:30 p.m. for purpose of a celebration of life/memorial in honor of Peter Anderson; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That _____ is hereby granted permission for use of South Beach on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantees indemnifying the City is executed; and provided the organization meets the terms and conditions set forth by the City Manager.

Section 2: That pursuant to Section 18-86 of the Key West Code of Ordinances, permission is granted to allow the sale and consumption of alcoholic beverages within the enclosed area.

Section 3: That _____ will adhere to the recycling plan of the City of Key West and that they will submit a recycling plan before the event.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
