TO CONDUCT THEIR 17th ANNUAL HALF MARATHON AND 5K RUN ON SATURDAY, JANUARY 17TH FROM 12:00 NOON TO 7:00 P.M. AND SUNDAY, JANUARY 18, 2015 FROM 6:00 A.M. TO 12:00 NOON AT THE HALF SHELL RAW BAR 231 MARGARET STREET; AUTHORIZING CERTAIN STREET CLOSURES THEREOF DURING THE EVENT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The Key West Half Marathon, Inc. is hereby given permission to the Key West Annual Marathon, Inc. to conduct the 17th Annual Key West Marathon, Inc. on Saturday, January 17th and Sunday, January 18, 2015;

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida:

SECTION 1. That permission is hereby granted to conduct the Half Marathon and 5K on the date and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

SECTION 2. That the Key West Half Marathon, Inc. is hereby granted permission for the closure of certain streets throughout the city for the Half Marathon & 5K on the date and during the hours stated above.

SECTION 3. That the Key West Half Marathon, Inc. will be coordinating with the agencies outside of the City of Key West jurisdiction for their part in the race.

SECTION 4. That the Event organizers will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that

they will be placed side by side.
