SECTION 2. That the Key West Gator Club is hereby granted permission for the closure of certain streets throughout the city for the Marathons on the date and during the hours stated above.

SECTION 3. That the Key West Gator Club is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and
