Section 1: That the purchase of three (3) new Horton Ambulances in a total amount not to exceed \$387,291.00, from Hall-Mark Fire Apparatus, pursuant to government contract, pursuant to section 2-797(3) of the code of ordinances, is hereby approved.

Section 2: That the purchase of one (1) used 2009 Ford E-450 Medtec Ambulance in a total amount not to exceed \$8,209.00, pursuant to section 2-771(3)(a) of the code of ordinances, is hereby approved.

Section 3: That necessary budget transfers are authorized from the Infrastructure Surtax Reserves 101-1900-519-94.00 to Infrastructure Surtax Fire Department Machinery and Equipment 101-2201-522-6200 for FY 13-14 (funds were originally to be budgeted for FY 14-15).

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
