A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A PURCHASING EXCEPTION PURSUANT TO SECTION 2-797 OF THE CODE OF ORDINANCES, TO ALLOW AN INCREASE IN CUMULATIVE EXPENDITURES DURING 13-14 TO ROY'S AUTO PARTS (\$4,000.00) INCREASE TO A TOTAL OF \$39,600.00), BANNER (\$4,500.00 INCREASE TO A TOTAL OF \$36,200.00), GILLIG LLC (\$15,000.00 INCREASE TO A TOTAL OF \$2,063,875.66), FLAMINGO OIL (\$11,500.00 INCREASE TO TOTAL \$33,500.00), AND THERMO KING (\$5,000.00 INCREASE TO A TOTAL OF \$8,078.02); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$20,000.00; and

WHEREAS, City staff has several sole source providers which are essential to day to day operations; and

WHEREAS, in Resolution 13-302, the City Commission approved purchasing exceptions for a number of sole source and/or blanket purchase orders in excess of \$20,000.00, including the five vendors listed above; and

WHEREAS, the above-listed vendors supply sole source repair and service parts, and fuel for City transit and fleet operations, which are functions essential to the health and welfare of the citizens of the City of Key West; and

WHEREAS, the City Manager finds that pursuant to section 2-797(4), it is in the best interest of the City to authorize

increase the amount of authorized expenditures previously approved in Resolution 13-302 from the five vendors named herein.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That an increase to the expenditure of funds previously authorized in Resolution No. 13-302 is hereby approved for: (1) Roy's NAPA Auto Parts (\$4,000.00 increase to a total of \$39,600.00), (2) Banner Tire (\$4,500.00 increase to a total of \$36,200.00), (3) Gillig LLC (\$15,000.00 increase to a total of \$2,063,875.66), (4) Flamingo Oil (\$11,500.00 increase to a total of \$33,500.00), and (5) Thermo King (\$5,000.00 increase to a total of \$8,078.02) in accordance with Key West City Code of Ordinances section 2-797(4)(b).

Section 2: That necessary budget amendments are hereby authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
