A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF ONE (1) 2015 FORD F250 WITH LIFT FOR \$27,536.50 FROM ALAN LINCOLN MERCURY PURSUANT TO SECTION 797(4)(b) OF THE CODE OF ORDINANCES; AND AUTHORIZING THE PURCHASE OF ONE (1) FORD CARGO VAN \$37,607.00 FROM ECONOLINE FOR THE DUVAL FORD, FOR USE BYKEY UTILITIES DEPARTMENT, THROUGH PIGGYBACKING SHERIFF'S THE FLORIDA **ASSOCIATION** CONTRACT, PURSUANT TO SECTION 2-797(3) THE CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, City staff recommends purchase of these vehicles as necessary replacements for vehicles which have exceeded their useful life; and

WHEREAS, the City Manager recommends purchase of the 2015 Ford F250 pursuant to section 2-797(4)(b) of the code of ordinances, in the best interests of the City, as the dealer price quote for a model year 2015 vehicle, is based on the 2014 Florida Sheriff's Association contract; and

WHEREAS, the purchase of the Ford Econoline Cargo Van from Duval Ford will be made under government contract, pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of one (1) 2015 Ford F250 With Lift Gate described in the attached proposal of Alan Jay Ford Lincoln Mercury, pursuant to section 2-797(4) of the Code of Ordinances, the best interests of the City, in the total amount of \$27,536.50, is hereby authorized.

Section 2: That the purchase of one (1) Ford Econoline Van described in the attached proposal of Duval Ford, pursuant to Section 2-797(3) of the Code of Ordinances, under the Florida Sheriff's Association Contract, in the total amount of \$37,607.00 is hereby authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
