A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING CHANGE ORDER NUMBER ONE FROM DOUGLAS N. HIGGINS IN THE AMOUNT OF \$15,825.40 FOR TASKS AND MATERIALS RELATED TO AN INCREASED SCOPE OF WORK ON THE NAVY MOLE PIER FENDER REPLACEMENT PROJECT (OM 1302); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 14-195, the City Commission awarded the bid for the Navy Mole Pier Fender Replacement Project to DN Higgins; and

WHEREAS, the Navy requested to increase the scope of work, to include procurement and installation of "friction strip" protective pads and additional installation of hardware, including two stainless steel ladders and 12 galvanized steel pad eyes; and

WHEREAS, the expenditure for this expanded scope of work exceeds five percent of the original contract amount, and pursuant to the code of ordinances section 2-895, City Commission approval is required;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That Change Order Number One to Project OM 1302 to Douglas N. Higgins, attached hereto, is approved in an amount not to exceed \$15,825.40 for additional tasks related to the Navy Mole Pier Fender Replacement Project.

Section 2: That the City Manager is authorized to execute any necessary documents, upon the advice and consent of the City Attorney, that are consistent with Change Order Number One and the approval granted herein.

Section 3: That this project is adequately funded in the FY 2014 budget under account #602-1900-519-4600 (the project award, including Change Order 1 totals \$235,535.40, while \$300,000.00 is budgeted for FY 2014).

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
