A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A PURCHASING EXCEPTION PURSUANT TO SECTION 2-797(1) OF THE CODE OF ORDINANCES, TO ALLOW AN INCREASE NOT TO EXCEED \$16.150.00 IN CUMULATIVE EXPENDITURES DURING FY 13-14 TO METLER TOLEDO ON A SOLE SOURCE BASIS (\$16,150.00 INCREASE TO PURCHASE ORDER 77037 TO A TOTAL OF \$30,704.00); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$20,000.00; and

WHEREAS, Metler Toledo is the sole source provider for repair and maintenance of the scales at the Solid Waste Transfer Station, which are essential to day to day operations and must be provided in working condition when transfer station operations are turned over to Waste Management; and

WHEREAS, a fully operational Solid Waste Transfer Station is essential to protect the health and welfare of the citizens of the City of Key West; and

WHEREAS, the City Manager finds that pursuant to sections 2-797(1) and 2-797(4), it is in the best interest of the City to authorize an increase of the amount of authorized expenditures for sole source vendor Metler Toledo.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That an increase in an amount not to exceed \$16,150.00 to funds previously authorized in Purchase Order 77037 is hereby approved for Metler Toledo (\$16,150 increase to a new total of \$30,704) as a sole source procurement, pursuant to Key West City Code of Ordinances section 2-797(1).

Section 2: That funds for this purchase are budgeted in line item 403-3402-534-46.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
