**WEDNESDAY, SEPTEMBER 10, 2014**

A regular meeting of the Key West Bight Management District Board of the City of Key West, Florida, was held in Commission Chambers, Old City Hall, 510 Greene Street, on Wednesday, September 10, 2014.

The Vice-Chairman called the meeting to order at 5:01 p.m.

**APPROVE OF AGENDA:**
