**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING WE CYCLE, INC. TO CONDUCT THE ANNUAL ZOMBIE BICYCLE RIDE EVENT STARTING AT EAST MARTELLO TOWERS AND ENDING ON THE 100, 200 & 300 BLOCK OF DUVAL STREET ON SUNDAY, OCTOBER 19, 2014, FROM 6:00 P.M. TO 11:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF THE 100, 200, 300 BLOCKS OF DUVAL STREET ON SUNDAY, OCTOBER 19, 2014 FROM 6:00 P.M. TO 11:00 P.M.; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, We Cycle, Inc. request permission to hold the annual Zombie Ride on Sunday, October 19, 2014 from 6:00 p.m. to 11:00 p.m.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida;

**SECTION 1.** That We Cycle, Inc. is hereby granted permission to conduct the annual Zombie Ride on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

**SECTION 2.** That We Cycle, Inc. is hereby granted permission for the closure of the 100, 200 & 300 blocks of Duval Street on the date and during the hours stated above for the ending of the ride.

**SECTION 3.** We Cycle, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrel will be used and that they will be placed side by side.

**SECTION 4.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
