A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE KEY WEST ART CENTER TO CONDUCT AN ART SHOW ON SATURDAY, FEBRUARY 21, 2015 AND SUNDAY, FEBRUARY 22, 2015 (STREET CLOSED FROM FEBRUARY 21, 2015 6:00 A.M. THROUGH FEBRUARY 22, 2015 8:00 P.M.) DURING THE HOURS OF 10:00 A.M. TO 5:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF WHITEHEAD STREET BETWEEN GREENE STREET AND EATON STREET INCLUDING CAROLINE BETWEEN TELEGRAPH & WHITEHEAD ON FEBRUARY 21, 2015 AND FEBRUARY 22 2015 FROM 10:00 A.M. TO 5:00 P.M.; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The Key West Art Center wishes to conduct an Art Show on the day and during the hours stated above, and

WHEREAS, The Key West Art Center anticipates that over 10,000 people will be participating in the event.

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida;

SECTION 1. That the Key West Art Center is hereby granted permission to conduct an Art Show on the day and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the city is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

SECTION 2. That the Key West Art Center is hereby granted permission for the closure of Whitehead Street between Greene Street and Eaton Street including Caroline Street between Telegraph & Whitehead on the date and during the hours stated above.

SECTION 3. That the Key West Art Center will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that

they will be placed side by side.

SECTION 4. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
