A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, GRANTING PRELIMINARY AUTHORIZATION TO ENTER INTO THE AGREEMENT PROCESS DEVELOPMENT AND PURSUE NEGOTIATIONS WITH THE PROPERTY OWNER FOR THE PROPERTY LOCATED AT 5555 COLLEGE ROAD (RE # 00072080-001400, AK # 1076007) PURSUANT TO SECTION 90-679 OF THE LAND DEVELOPMENT REGULATIONS OF THE CODE OF ORDINANCES OF THE CITY OF KEY WEST, FLORIDA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, pursuant to Section 90-679 of the Land Development Regulations (the "LDRs") of the Code of Ordinances (the "Code") of the City of Key West, Florida (the "City"), the City Commission is allowed to determine whether it is willing to consider entering into a proposed development agreement prior to the commencement of the normal process of approving a development agreement.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission is amenable to considering a preliminary request for a development agreement for the proposed development of new non-transient residential dwelling units at the Sunset Marina property located at 5555 College Road (RE # 00072080-001400, AK # 1076007) in accordance with City Code Section 90-679 with the following condition:

1. The requirements of City Code Chapter 90, Article IX shall be fully complied with to the satisfaction of the City Attorney.

<u>Section 2</u>: That <u>Sunset Marina, LLC</u> is encouraged to work with Planning and City staff in the submission of such a development agreement for City Commission consideration.

<u>Section 3</u>: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
