A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING BOAT RAMP AND BOAT TRAILER PARKING FEES AT THE CITY MARINA AT GARRISON BIGHT; APPROVING AND IMPLEMENTING AN ANNUAL COMMERCIAL BOAT RAMP FEE; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, fees for using the boat ramp and boat trailer parking facilities at the City Marina at Garrison Bight, were established in Ordinance No. 91-33, and have not been adjusted since 1991; and

WHEREAS, a recent rate study recommended an increase to fees to help support the cost of operation and repairs; and

WHEREAS, City staff recommends adjusting fees accordingly, and implementing additional fee options for commercial use of the boat ramp and trailer parking area at the City Marina at Garrison Bight; and

WHEREAS, other fees and rates at the City Marina at Garrison Bight are established and adjusted by Resolution, and so staff recommends that adjusted fees for boat ramp use and boat trailer parking shall be established in this resolution, presented concurrently to the Commission for approval upon the repeal of ordinance 91-33.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That commencing on ______ 2014, the following fee schedule shall apply for use of the boat ramp and trailer parking area at the City Marina at Garrison Bight:

Boat Ramp fee per launch	\$10.00
Annual boat ramp fee, recreational	\$90.00
Annual boat ramp fee, commercial	\$1,500 00
Daily parking fee boat trailer	\$10.00
Daily Parking fee oversized boat trailer	\$20.00

Section 2: That owners and users of any car, truck, trailer or other vehicle parking in the parking area adjacent to the boat ramp shall pay a parking fee for each day, or portion thereof.

Section 3: That the commercial ramp annual fee shall include unlimited use of the ramp for launching and parking for one (1) trailer daily for a term of one year. Commercial operators shall provide the City with proof of business license, vessel registration and liability insurance.

Section 4: All customers using the boat launch and/or
trailer parking area shall obey all applicable Rules and Regulations
of the City Marina at Garrison Bight.
Section 5: That this Resolution shall go into effect
immediately upon its passage and adoption and authentication by the
signature of the Presiding Officer and the Clerk of the Commission.
