A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN PURCHASE APPROVED BY THE EMERGENCY MANAGER IN EXCESS OF \$20,000 AS ALLOWED UNDER SECTION 2-797(2) OF CITY'S CODE OF ORDINANCES, FOR THE PURCHASE OF MECHANICAL INTEGRITY TESTING FOR THE RICHARD A. HEYMAN ENVIRONMENTAL PROTECTION FACILITY INJECTION WELLS BY LAYNE CHRISTENSEN COMPANY IN THE AMOUNT OF \$79,651.00, AT THE SAME SPECIFIED IN BROWARD COUNTY CONTRACT Y1128904C1; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Chapter 62-529, F.A.C., requires that each injection well must undergo mechanical integrity testing (MIT) every five years, and the injection wells IW-1 and IW-2 for the Richard A. Heyman Environmental Protection Facility must complete testing by December 1 and December 6, 2014, respectively; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to procure a contract with Layne Christensen Company in the amount of \$79,651.00 for MIT for the injection wells, at the same rates set forth in Broward County Contract No. Y1128904C1; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission, in accordance with Section 2-797(2) of the City of Key West Code of Ordinances, hereby ratifies the City Manager's emergency authorization for the procurement in the total amount of \$79,651.00 for mechanical integrity testing services from Layne Christensen Company, as described in the attached contract.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
