MEDICAL QUALIFICATIONS AND RELEVANT EXPERIENCE

1. Currently licensed and practicing in the State of Florida as a M.D. or D.O. for at least two (2) years.

Doctor McGrath has been licensed as a M.D. since 2007, and his current Florida license was just renewed and expires January 31, 2017. He has full staff privileges and practices emergency medicine at the Lower Keys Medical Center in Key West, along with Fisherman's Hospital in Marathon, FL. Dr. McGrath is a full time resident of Key West.

- The proposer must have the ability to prescribe medications, including controlled substances, in the State of Florida, pursuant to the provisions of Chapters 458, 499, and 893 of the Florida Statutes.
- Dr. McGrath holds a Florida DEA license that allows the prescribing of all medically useful controlled substances (Schedule II-V). There are no restrictions on his Florida medical license regarding the prescribing of non-controlled or controlled substances.
- The proposer shall be active in a broad based clinical medical specialty with demonstrated experience in prehospital care.

- Broad knowledge base of pre-hospital and hospital emergency medicine and/or emergency surgery. Pre
 hospital care experience shall be provided by the proposer.
- Dr. McGrath first became involved with EMS in 1988, and became a licensed paramedic in 1992. In 1994 he became a full-time professional firefighter with the City of Hartford, Connecticut. He was promoted to Ladder Driver in 1998 and Lieutenant in 1999. During his subsequent years he was assigned to the training division, where he oversaw the medical training of firefighters and recruits as a state certified EMS Instructor, Basic Life Support Instructor, and Advanced Cardiac Life Support Instructor. During this time he coordinated the EMS and fire department coverage of numerous large scale outdoor events, such as the Dave Matthews concerts and multiple street festivals and parades. He also coordinated and responded with a large HFD mutual aid contingent to the World Trade Center disaster site on September 11, 2001. He continues to be involved with the World Trade Center Health Registry.

After medical school Dr. McGrath became a Command Physician with City of Pittsburgh Bureau of EMS, during which time he logged over 200 scene responses, along with participating in the training and continuous quality improvement (CQI) process for the Pittsburgh Paramedics. He also served as a Stadium Physician for the Pittsburgh Steelers and Pittsburgh Penguins, a Flight Physician with the Stat MedEvac helicopter program, and was the Assistant Medical Director of Munhall (PA) EMS.

Dr. McGrath is board certified in emergency medicine by the American Board of Emergency Medicine (ABEM) through December 31, 2022. He is a full-time practicing emergency medical physician, and also holds an academic appointment as an Assistant Professor of Emergency Medicine at the Boonshoft School of Medicine at Wright State University, instructing military and civillan emergency medicine residents along with medical and paramedic students. He is also a Fellow with the American Academy of Emergency Medicine, and belongs to the National Association of EMS Physicians (NAEMSP). He has completed the NAEMSP EMS Medical Directors Course, along with the Ohio Chapter of the American College of Emergency Medicine's EMS Medical Directors Course. Dr. McGrath holds undergraduate degrees in public policy and economics.

- The proposer is preferred to be Board Certified in Emergency Medicine or the American Board of Osteopathic Emergency Physicians for at least two (2) years.
- Dr. McGrath is board certified in emergency medicine by the American Board of Emergency Medicine (ABEM) through December 31, 2022.
- Within six (6) months of contract signing, the proposer must provide both Advanced Cardiac Life Support (ACLS) instruction and Advanced Trauma Life Support (ATLS) instruction.
- Dr. McGrath has already achieved certification in Advanced Cardiac Life Support (ACLS) and Advanced Trauma Life Support (ATLS). He is also certified as a provider and instructor in Advanced Hazardous Materials Life Support (AHLS).
- The proposer must be certified as a provider in Basic Trauma Life Support (BTLS) and/or Pre-hospital Trauma Life Support (PHTLS), and be certified in Pediatric Advanced Life Support (PALS).
- Dr. McGrath is currently certified in Advanced Trauma Life Support (ATLS), which fulfills this requirement as per Addendum No.1. He is also currently certified in Pediatric Advanced Life Support (PALS).

TAB III

COST OF SERVICES TO THE CITY

Cost of Services to the CITY

- 1. We propose an initial three (3) year contract, with options for at least three (3) consecutive one (1) year renewal periods. The initial three-year contract is the optimum time period to develop and allow a new EMS system to mature. An initial one (1) year contract simply does not provide enough time to obtain the metrics and feedback necessary to allow the continuous quality improvement (CQI) process to create the highest level of service possible. The ultimate goal is that EMS personnel will deliver the same quality of medical care that an emergency physician would have directly rendered if they were on the scene themselves.
- Under the RFP's Scope of Services, section C "duties and responsibilities", number 16 states Provide the system with continuous on-line medical control twenty four (24) hours per day, seven (7) days per week, which shall include medical direction to personnel, resolve system conflicts, and provide services in an emergency as defined in Section 252.34(3).

Based on 2013 data, Care Ambulance received 5,603 calls for service. In order for the vendor to directly supply continuous 24/7 on-line medical control and medical direction to personnel for this number of responses, we would require four full-time dedicated emergency physicians at a cost of \$1,400,000.00.

We believe a superior option would be to continue to have emergency physicians at Lower Keys Medical Center provide the continuous 24/7 on-line medical direction. This is the current practice in the Keys and is also the traditional model across the country, with the exception of some very large cities that have dedicated full-time EMS physicians. We will provide base station training to the emergency physicians and nurses regarding the newly developed EMS protocols and KWFD EMS capabilities. We will be available 24/7 for resolution of system conflicts, unique or unexpected outcome cases, and to provide services and consultation in an emergency as defined in Section 252.34(3). Calls for online medical control will be reviewed as part of the CQI system. Dr. McGrath wishes to be accessible to all KWFD personnel, and if they feel they have an emergent issue he would welcome their call anytime day or night. All KWFD firefighters and paramedics will be provided with Dr. McGrath's personal cell phone number and email address.

Although the difference between these two options may not be highlighted by other vendors, it is not realistic to expect one or two physicians to take calls from paramedics for medical direction night and day potentially 5,603 times a year.

With this preferred second option, the proposed cost for EMS medical direction for the City
of Key West is \$84,000.00 per year. Our research shows that the current medical director
for unincorporated Monroe County, Marathon, and Islamorada is paid \$94,000.00,
\$27,520.00, and \$36,465.12 respectively. In addition to the contract fee, each of these

municipalities is presumably paying for all insurances, including medical malpractice for their respective region. Assuming average annual malpractice insurance costs of \$21,500.00 per year, the total annual cost for salary and malpractice insurance for the EMS medical director paid by Monroe County, Marathon and Islamorada combined exceeds \$222,000.00. According to the Key West Chamber of Commerce, Key West contains 32% of all Keys full time residents, but this does not take into account the 2,668,892 yearly overnight tourists, day visitors, and cruise ship passengers. This number also does not include military visitors and civilian support staff. These numbers will only increase as more than 500 hotel rooms come online in the next few years, all of which increases the work load and medicolegal liability for the EMS Medical Director.

Given our highly detailed approach to establishing what will hopefully become a national model for similar EMS systems, we believe that the proposed cost to the City is more than fair. We may not be the lowest bidder, but the old adage "you get what you pay for" rings true, especially when it comes to EMS oversight, or lack of it. As a citizen of Key West, self-interest drives me to work as hard as possible to create an excellent EMS system so that my family, friends, and neighbors will have the best possible EMS care if and when the need should arise. Although not everyone will require a fire truck to come to their house, there are very, very few who will never require an ambulance.

- 4. We also request that the City pay up to a maximum of \$5,000.00 per year as reimbursement of expenses such as travel and lodging to contractually required meetings, contractually required certification courses, EMS medical director conference attendance, monthly journals for each firehouse, and stipends/honoraria for outside speakers and instructors who are experts in their field.
- Medical Malpractice in the amount of \$1,000,000 per claim including tail coverage will be funded by Dr. McGrath (cost \$21,500.00 per annum).
- 6. If an intoxication observation unit is formed at the Keys Overnight Temporary Shelter (KOTS), we will provide medical oversight at <u>no charge</u> to the City. Keeping an intoxicated individual in the shelter with EMT supervision instead of sending them to the hospital or jail has the potential to save the City and County hundreds of thousands of dollars each year.
- 7. Additional Requirements of the City
 - A. Provide private office space along with office furniture, supplies, and equipment, including a computer with internet connectivity and email address for official use by the Medical Director in performance of the duties and responsibilities specified in the agreement.
 - B. Provide appropriate secretarial and clerical support for activities directly related to the Medical Director's position and responsibilities.
 - C. Provide two sets of uniforms yearly, one set of labeled personal protective apparel and equipment, and a Medical Director's ID badge to be worn by the Medical Director during emergency incident responses or field-related activities.

- D. Provide a cellular telephone and digital pager for official use by the medical director in performance of the duties and responsibilities specified in this Agreement.
- E. Provide a portable radio with current EMS frequencies, along with fire and police dispatch channels. Establish an official radio title or designation to identify the Medical Director during radio or electronic communications conducted on the Key West Fire Department voice and data transmission networks.
- F. Provide insurance or formal indemnification of the Medical Director against claims, suits, and judgments of liability for all acts or omissions that are within the course and scope of duties and responsibilities that are specified in this agreement except for those acts or omissions covered by the Medical Director's medical malpractice policy.
- G. Provide direct 24 hour a day, 7 day a week access to an emergency response vehicle, clearly marked and maintained by the City or KWFD. This vehicle is to be equipped with a full compliment of ALS medical equipment and supplies.

TAB IV

COMMITMENT TO CLINICAL PERFORMANCE

Commitment to Clinical Performance

Supervise and accept direct responsibilities for the medical performance of the paramedics and EMT's
working for the City. Medical Director will retain the ultimate authority to permit and/or prohibit any paramedic
or EMT to use advanced life support or other emergency medical procedures. The area of responsibility will
include, but not be limited to, on-duty field personnel, on-duty command personnel, and dispatch personnel.

We will provide medical direction, oversight and quality assurance of all medical aspects of public safety (EMS, fire, police), homeland security, and public health emergencies in the City; serve as the City's representative to the medical community at large; and develop research and external funding sources for training and mitigating public safety, homeland security, and public health emergency events. If requested, we are also willing to provide tactical emergency medical support and training.

We will review the current EMS dispatch system, and assist in developing a robust Emergency Medical Dispatch (EMD) program with Continuous Quality Improvement (CQI). This includes goals of minimizing the time from call receipt to dispatch in critical cases, approving pre-arrival instructions given to all callers, and decreasing City liability from ambulance crashes by developing protocols to determine which medical requests for assistance do not require the use of a "hot" response with lights and sirens.

Continually evaluate the medical capability of the paramedics and EMT's of the Key West Fire Department and offer advice regarding the appropriate levels and standards of care that should be achieved. This evaluation will be accomplished through written testing, performance-based testing, and direct observation during patient transport and treatment events.

To effectively evaluate the paramedics, one must get to know them. Dr. McGrath will meet with each paramedic individually prior to the "go live" date, again within the following 90 days, and then at least annually. These meetings will provide significant feedback on the success or setbacks regarding our policies, protocols, and procedures.

Evaluation and ongoing training will be multifaceted and extensive, and we intend to work very closely with the KWFD training staff. There will be written protocol and computerized scenario based testing prior to the "go live" date, and at regular intervals thereafter. We also propose to implement a level of performance-based training that has not been previously utilized by EMS in the Keys, by utilizing high fidelity robotic simulation mannequins (currently available at LKCC) which are almost life-like in appearance and function, thus allowing for immediate feedback and the ability to change the scenarios based on individual performance. We will assist in procuring grants and lobbying for funding so that the KWFD can acquire their own simulation robots.

Our training standards will be based on the latest evidenced-based medical research available. We anticipate also creating live simulated patient encounters with local actors, which will allow dynamic interaction and a direct evaluation of a paramedic's ability to

obtain a proper history, physical exam, and form the correct treatment plan. An annual cadaver lab will be planned to allow emergency procedures to be practiced on recently deceased, lightly embalmed cadavers. This will also provide an excellent review of anatomy "from the inside out," which is invaluable in understanding the pathology of disease processes. We would also be happy to assist in the development of a modern EMS training center in a KWFD facility. This would allow for future in-house paramedic training, along with a location for monthly continuous medical education classes, both of which would save tax dollars.

Direct observation during patient treatment and transport events by the Medical Director is the backbone of a successful EMS program. No program can be truly successful without such a component. It allows the Medical Director to serve as an immediate "risk manager" in logistically difficult situations, such as patient refusals, termination of resuscitative measures, and interference by outside random health providers. The presence of a physician on scene can calm families and diminish complaints and threatened legal action. Periodic direct physician response also improves paramedic training, morale, and patient care by providing "real world" mentorship, interaction, and supervision. Without such response, providers operate in a void of proper role modeling or feedback, and oversight only occurs after the patient arrives at the emergency department, resulting in a vast amount of missed learning and corrective opportunities.

We will also oversee the process of allowing newly hired or newly licensed paramedics to work independently in the pre-hospital setting through ride-alongs and shifts with Dr. McGrath in the emergency department.

- 3. Develop medically correct EMS Protocols that permit specific ALS procedures be used when field paramedics cannot establish communication at a receiving hospital, or when a delay in patient care would potentially threaten the life or health of the patient. Furthermore, these orders will also state allowed ALS procedures that may be performed before the establishment of communication with a physician at a receiving hospital.
 - Field paramedic input is vital in creating effective and practical ALS protocols, especially given the island's unique characteristics and challenges. We will oversee and participate in a committee of KWFD paramedics who will review current protocols utilized by Care Ambulance along with those employed in other regions across the state and country. Combined with intense training, the development of state of the art, aggressive ALS protocols will make a tremendous difference in patient outcomes and satisfaction.
- Annually review the EMS protocols for accuracy within local, state, and federal standards of care guidelines.
 To accept responsibility for the medical correctness of any standing order that he/she authorizes for use and for properly instructing regarding the correct use of standing orders.

Given the rapid rate of change in evidenced-based treatments and standards of care, we propose to review the EMS protocols every 6 months. Our ultimate goal would be to have the protocols accessible on the internet, with smartphone access via an "App", allowing for instant reference, updates, and rapid dissemination of Information.

- Develop EMS protocols that ensure the transport of patients to facilities that offer a type of level of care appropriate to the patient's condition (e.g. Trauma Transport Protocol).
 - We will develop transport and treatment protocols for patients with severe pediatric, cardiac, traumatic, or neurologic issues whose disease complexity prevents their admission to the local hospital.
- Develop medically correct EMS protocols, which permit EMT's to perform specified advanced BLS
 procedures. These procedures will include but not be limited to normal day to day BLS functions,
 automatic/semiautomatic defibrillation, esophageal intubation and inter facility monitoring and maintenance
 of non-medicated intravenous therapy.
 - We will develop appropriate, modern, and evidence-based protocols based on the most recently available research to maximize the effectiveness of KWFD EMT's.
- Prepare and maintain a written document that outlines any deviations to the Trauma Transport Protocol including the circumstances and Medical Director's opinion.
 - This will be managed through a Continuous Quality Improvement (CQI) committee that shall meet monthly. For maximum effectiveness, it is proposed that this committee consist of the Medical Director, KWFD leadership, union representatives, and field paramedic volunteers. Besides random chart audits, during the first year of operation 100% of all charts will be reviewed whenever there is advanced procedure utilization (i.e. intubation, cricothyrotomy, chest decompression, etc.), cardiac arrest, traumatic arrest, or if the patient requires helicopter evacuation. Chart audits will also occur 100% of the time there is implementation of a new medication/procedure, or after any "high profile" incident that gathers widespread media or public attention. Any deviations from established protocols or procedures will always be reviewed, and appropriate action taken if necessary. Root cause analysis sessions will be convened in cases of equipment failure, medication errors, and motor vehicle crashes while transporting a patient.
- Create, authorize, and ensure adherence to detailed written operating procedures regarding all aspects of the handling of medications, fluids and controlled substances, and accept responsibility that the security procedures meet Chapters 499 and 893 F.S and 64J-2 F.A.C

We will assist and coordinate with the Fire Chief (or designee) in the writing of operating procedures creating, authorizing, and confirming adherence to the rules and regulations regarding all aspects of the handling of medications, fluids, and controlled substances using security procedures that meet Chapters 499 and 893 F.S. and 64J-2 F.A.C. However, the physical security involving storage and inventory of all medications, fluids, and controlled substances is solely the responsibility of the Key West Fire Department.

Ensure that all EMT's and paramedics in the system are trained in the use of the trauma scorecard methodology as provided in Section 64J-2 F.A.C.

We will ensure completion of trauma scorecard methodology training prior to the "go live" date.

 Develop and/or approve a forty (40) hour EMT and forty (40) hour paramedic refresher course for the biennial certification process, which is based on the 24/48 shift worked by field personnel.

We will assist in the development of the above refresher courses utilizing classroom lectures and practicum along with computerized self-study modules; however, we believe that the comprehensive educational component provided will far surpass state and national standards. For instance, we plan to offer staged mass casualty events (such as a car into a crowd) using actors and high achool students in appropriate costume and moulage, along with events simulating hazardous material exposures and terrorist attacks. We will do our best to ensure that all training is eligible for State of Florida CME credit.

 Develop and/or approve other selected topics as required by local, state, and federal laws, (e.g. communicable diseases, SIDS, etc.)

We will rapidly disseminate this information through a newsletter or email blast based on priority or severity, followed by more formal training.

12. Develop and/or participate in a patient care Quality assurance program to assess the medical performance of paramedics and EMT's. Auditing of personnel will include but not be limited to a prompt run report review, direct observation on emergency scenes as well as on transport units and comparison of performance standards for drugs, equipment, protocols, and procedures.

A Continuous Quality Improvement (CQI) Committee will be established as noted above in #7 of this section. A robust scene response program to allow for direct observation on emergency scenes as well as aboard transport units will be established as noted in #2 (paragraph 3) of this section.

 Notify the Bureau of EMS in writing when there is a substitution of equipment or medication as directed by Section 84J-2 F.A.C.

Agreed. We will also institute "just-in-time" standing orders to allow for immediate substitutions if a medication or piece of equipment is on backorder due to the current nationwide drug shortage crisis.

 Conduct periodic review sessions with KWFD personnel in regards to medical management of individual cases.

As noted above in #2, Dr. McGrath will have one-on-one meetings with all paramedics prior to the "go live" date, again within the following 90 days, and then at least annually. Individual meetings may also occur at any time if requested by KWFD personnel or Dr. McGrath to discuss a case or speak about any other concern.

In keeping with his philosophy of accessibility, Dr. McGrath plans to make regular visits to each firehouse for informal discussions regarding individual cases or to answer any questions. As Dr. McGrath has full staff privileges at the Lower Keys Medical Center, he will be able to supplement the educational experience by providing paramedics with feedback and follow up information on patients who were under their direct care in a HIPPA compliant manner.

 Recommend and/or approve equipment, medication, and Standing Orders for use by KWFD that meet or exceed Section 64J F.A.C.

We will work closely with KWFD staff to offer our opinions and guidance concerning any equipment they wish to acquire, and will assist in completing any available grant applications when possible. It is our expectation that we will exceed the requirements of Section 64J F.A.C. regarding medications and standing orders.

 Provide the system with continuous on-line medical control twenty four (24) hours per day, seven (7) days per week, which shall include medical direction to personnel, resolve system conflicts, and provide services in an emergency as defined in Section 252.34(3).

As discussed previously, we believe a superior option would be to continue to have emergency physicians at Lower Keys Medical Center provide the continuous 24/7 on-line medical direction. The money to hire four full-time physicians for this purpose could better be spent elsewhere. This is the current practice in the Keys and is also the traditional model across the country, with the exception of some very large cities that have dedicated full-time EMS physicians. Base station training to LKMC emergency physicians and nurses regarding the newly developed EMS protocols and KWFD EMS capabilities will be provided at no additional cost. Dr. McGrath will be available 24/7 for resolution of system conflicts, unique or unexpected outcome cases, and to provide services and consultation in an

emergency as defined in Section 252.34(3). Calls for online medical control will be reviewed as part of the CQI system. Dr. McGrath wishes to be accessible to all KWFD personnel, and if they feel they have an emergent issue he would welcome their call anytime day or night. All KWFD firefighters and paramedics will be provided with Dr. McGrath's personal cell phone number and email address.

17. Establish an emergency administrative call schedule in which an appointed physician will be on call during periods of vacation, holidays, and other occasions where the Medical Director may be unavailable for consultation/direction.

We agree to comply with the above. We also will only allow a board certified emergency medicine physician with pre-hospital experience to serve as an "appointed physician".

18. Serve as a liaison between KWFD senior management and the department's occupational physician with regard to annual employee physicals, medical clearances and matters involving health and wellness.

Agreed. Dr. McGrath also agrees to serve as a liaison between the KWFD and the local medical community by responding to questions, criticisms, concerns, or complaints from physicians, surgeons, and hospital personnel about the performances, policies, or practices of the EMS division of the KWFD and its agents, representatives, members, and employees.

Whenever requested by the Chief of KWFD or delegate, Dr. McGrath will respond to questions, criticisms, concerns, or complaints from citizens, patients, and the news media about the performances, policies, and practices of the EMS system and its agents, representatives, members, and employees.

- Develop system to review and evaluate new medications, EMS equipment and innovative EMS patient care modalities for possible implementation, possibly improving patient care to the City of Key West.
 - Dr. McGrath will participate in committees, conferences, and continuing education that will bring new medications, equipment, and modalities to the forefront of the KWFD EMS service. This will include attending the ClinCon and National Association of EMS Physicians annual conferences. KWFD EMS senior staff will also be encouraged to attend these conferences.
- Review emergency medical procedures for possible elimination of medications, equipment, and treatment modalities that no longer provide effective and efficient care and treatment for emergency patients.

This will occur at least every six (6) months during review of ALS and BLS protocols, or immediately if there is a change in national consensus.

- Advanced Trauma Life Support (ATLS) certification is acceptable in place of Basic Trauma Life Support (BTLS) or Pre-Hospital Trauma Life Support (PHTLS).
- Within six (6) months of contract signing, the proposer must provide both Advanced Cardiac Life Support (ACLS) instruction and Advanced Trauma Life Support (ATLS) instruction.
- Indicate any exceptions to the general terms and conditions of the RFP requirements in Tab VII, Acceptance of Conditions.
- Same concern with BTLS and PHTLS as above in subsection 7.
- Basic Trauma Life Support (BTLS) and/or Pre-hospital Trauma Life Support (PHTLS), and PALS certifications are required.
- Advanced Trauma Life Support (ATLS) certification is acceptable in place of BTLS or PHTLS.
- Indicate any exceptions to the general terms and conditions of the RFP requirements in Tab VII, Acceptance of Conditions.
- In regards to the "State Medical Director's Association", is this the same organization as the Florida Association of Emergency Medical Services (FAEMSMD) referenced on page 2, B(1)?
- Yes, Florida Association of EMS Medical Directors (FAEMSMD) is the organization that the proposer must become active in.
- In regards to the "National Association of EMT's (NAEMT)", this is not an organization normally associated with EMS physicians, as it's focus is directly on

the daily activities of EMT's and paramedics rather than their medical direction. The EMS medical director group is the National Association of EMS Physicians (NAEMSP), which provides guidance and publishes research in the journal Prehospital Emergency Care (www.naemsp.org). Is this the professional group that was meant to be required?

- All professional memberships with exception of (FAEMSMD) are preferred, not required.
- Tab VI, Physician Group Involvement- committee members will award up to 10 points for verifiable professional memberships.
- Indicate any exceptions to the general terms and conditions of the RFP requirements in Tab VII, Acceptance of Conditions.
- 5. In regards to the "Florida Association of Certified Emergency Physicians (FACEP)", to my knowledge no such group exists. There are two national emergency physician associations, and both do have Florida chapters: The American Academy of Emergency Medicine (AAEM) and the American College of Emergency Physicians (ACEP). AAEM membership is composed primarily of clinical emergency physicians, and ACEP has a focus more appropriate for academic/research physicians. Is membership in either group what was meant to be required?
- The Florida Chapter of American College of Emergency Physicians membership is preferred.

- Competitive solicitation means a formal process by the City of Key West relating to the acquisition of goods or services, which process is intended to provide an equal and open opportunity to qualified persons and entities to be selected to provide the goods or services. Completive solicitation shall include request for proposals ("RFP"), request for letters of interest ("RFLI"), invitation to bid ("ITB") or any other advertised solicitation.
- (2) Cone of silence means a period of time during which there is a prohibition on communication regarding a particular competitive solicitation.
- (3) Evaluation or selection committee means a group of persons appointed or designated by the city to evaluate, rank, select, or make a recommendation regarding a vendor or the vendor's response to the competitive solicitation. A member of such a committee shall be deemed a city official for the purposes of subsection (c) below.
- (4)
 Vendor means a person or entity that has entered into or that desires to enter into a contract with the City of Key
 West or that seeks an award from the city to provide goods, perform a service, render an opinion or advice, or make a recommendation related to a competitive solicitation for compensation or other consideration.
- (5)
 Vendor's representative means an owner, individual, employee, partner, officer, or member of the board of directors of a vendor, or a consultant, lobbyist, or actual or potential subcontractor or sub-consultant who acts at the behest of a vendor in communicating regarding a competitive solicitation.
- (b) Prohibited communications. A cone of silence shall be in effect during the course of a competitive solicitation and prohibit:
- (1) Any communication regarding a particular competitive solicitation between a potential vendor or vendor's representative and the city's administrative staff including, but not limited to, the city manager and his or her staff;

(2)Any communication regarding a particular competitive solicitation between a potential vendor or vendor's representative and the mayor, city commissioners, or their respective staff; Any communication regarding a particular competitive solicitation between a potential vendor or vendor's representative and any member of a city evaluation and/or selection committee therefore; and Any communication regarding a particular competitive solicitation between the mayor, city commissioners, or their respective staff, and a member of a city evaluation and/or selection committee therefore. Permitted communications, Notwithstanding the foregoing, nothing contained herein shall prohibit: Communication between members of the public who are not vendors or a vendor's representative and any city employee, official or member of the city commission; (2) Communications in writing at any time with any city employee, official or member of the city commission, unless specifically prohibited by the applicable competitive solicitation. However, any written communication must be filed with the city clerk. Any city employee, official or member of the city commission receiving or making my written communication must immediately file it with the city clerk. The city clerk shall include all written communication as part of the agenda item when publishing information related to a particular competitive solicitation; Oral communications at duly noticed pre-bid conferences; Oral presentations before publically noticed evaluation and/or selection committees; Contract discussions during any duly noticed public meeting; Public presentations made to the city commission or advisory body thereof during any duly noticed public meeting; Contract negotiations with city staff following the award of a competitive solicitation by the city commission; or Purchases exempt from the competitive process pursuant to section 2-797 of these Code of Ordinances; (d) Procedure. (1) The cone of silence shall be imposed upon each competitive solicitation at the time of public notice of such solicitation as provided by section 2-826 of this Code. Public notice of the cone of silence shall be included in the notice of the competitive solicitation. The city manager shall issue a written notice of the release of each competitive solicitation to the affected departments, with a copy thereof to each commission member, and shall include in any public solicitation for goods and services a statement disclosing the requirements of this ordinance. (2) The cone of silence shall terminate at the time the city commission or other authorized body makes final award or gives final approval of a contract, rejects all bids or responses to the competitive solicitation, or takes other action which ends the competitive solicitation. Any city employee, official or member of the city commission that is approached concerning a competitive solicitation while the cone of silence is in effect shall notify such individual of the prohibitions contained in this section. While the cone of silence is in effect, any city employee, official or member of the city commission who is the recipient of any oral communication by a potential vendor or vendor's representative in violation of this section shall create a written record of the event. The record shall indicate the date of such communication, the persons with whom such communication occurred, and a general summation of the communication.

Violations/penalties and procedures.

(1) A sworn complaint alleging a violation of this ordinance may be filed with the city attorney's office. In each such instance, an initial investigation shall be performed to determine the existence of a violation. If a violation is found to exist, the penalties and process shall be as provided in section 1-15 of this Code.

In addition to the penalties described herein and otherwise provided by law, a violation of this ordinance shall render the competitive solicitation void at the discretion of the city commission.

(3) Any person who violates a provision of this section shall be prohibited from serving on a City of Key West advisory board, evaluation and/or selection committee.

In addition to any other penalty provided by law, violation of any provision of this ordinance by a City of Key West employee shall subject said employee to disciplinary action up to and including dismissal.

If a vendor is determined to have violated the provisions of this section on two more occasions it shall constitute evidence under City Code section 2-834 that the vendor is not properly qualified to carry out the obligations or to complete the work contemplated by any new competitive solicitation. The city's purchasing agent shall also commence any available debarment from city work proceeding that may be available upon a finding of two or more violations by a vendor of this section.






