A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF CHARLEY TOPPINO AND SONS, INC. FOR PUMP STATION F IMPROVEMENTS, IN ACCORDANCE WITH THE TERMS SPECIFIED IN ITB 14-015, IN AN AMOUNT NOT TO EXCEED \$1,670,744.25; AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE CONTRACT DOCUMENTS CONTAINED IN THE BID PACKAGE AND UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on September 17, 2014 three bids were opened in response to ITB #14-015, for Pump Station F Improvements, and the bids were determined to be responsive; and

WHEREAS, the bid submitted by Charley Toppino and Sons, Inc. was the lowest responsive bid; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of Charley Toppino and Sons, Inc. for the Pump Station F Improvements Project in accordance with the terms specified in ITB #14-015 is hereby awarded in an amount not to exceed \$1,670,744.25.

Section 2: That funds in the amount of \$1,460,335.66 for this project are budgeted in account #402-3503-535-6500, and a necessary budget transfer in the amount of 210,408.59, as part of the award from reserve account 401-3501-535-9700 is hereby approved.

Section 3: That the City Manager is authorized to execute a contract in substantial conformance with the contract documents contained within the bid package on behalf of the City of Key West, upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and

authentication by the signature of the Presiding Officer
and the Clerk of the Commission.
