A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, ACCEPTING THE PROPOSAL OF CONSTRUCTION CO., INC. FOR CONSTRUCTION OF THE NEW KEY WEST CITY HALL AT GLYNN IN ACCORDANCE WITH THE TERMS ARCHER, SPECIFIED IN RFP 001-15, WITH A BASE AMOUNT NOT TO EXCEED \$15,236,557.00; AUTHORIZING CITY STAFF TO NEGOTIATE A CONTRACT TO BE PRESENTED THE COMMISSION CITY FOR FINAL APPROVAL; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on October 22, 2014 three proposals were opened in response to RFP #001-15, for construction of the new Key West City Hall at Glynn Archer, and the proposals were determined to be fully responsive; and

WHEREAS, ranking committee members submitted ranking scores of each quality packet to the City Clerk in sealed envelopes, which were opened and tabulated, along with pricing packets, at a properly noticed meeting conducted consistent with the "Sunshine Law," on October 30, 2014, to rank the respondents to the RFP; and

WHEREAS, the proposal submitted by Biltmore Construction Co., Inc. was the highest-ranked responsive proposal; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission concurs with the evaluation committee's recommendation and accepts the attached proposal of Biltmore Construction Co., Inc. for construction of the new Key West City Hall at Glynn Archer in accordance with the terms specified in RFP #001-15 with a base bid amount not to exceed \$15,236,557.00

Section 2: That the City Manager or his designee is authorized and directed to negotiate a contract to present to the City Commission for final approval.

Section 3: That the City Manager or his designee is hereby directed review the specifications for any potential deductive change orders that do not diminish the overall quality of the project.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
