

Comments:	I have a number of comments: 1) The trolleys & conch train should have a minimum number of passengers before they can start a tour. Snorkel & dive boat operators do this and there's no reason the trollleys & conch train can't as well. The busy Old Town streets should not be clogged by a tour vehicle doing 7 mph with only 2 or 4 people aboard. 2) The trolleys & conch train should restricted to side streets during rush hours (i.e. 7-9am 8 4-6pm) and not be allowed to use the main commuter routes like Eaton & Truman that people use to get to & from work. 3) If they are allowed to use the main thoroughfares during rush hours, they should have to turn off after 3-4 blocks so as not to block people trying to get to & from work. 4) For narrations, the trolleys and conch train should use individual headsets for each passenger instead of loudspeakers that blast into the neighborhood. 5) The narrations given by the tour operators should be approved by the city so drivers and narrators don't just make stuff up about the city. Every tour I have ever taken has had blatantly untrue statements given out as facts.
