A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A SOLE SOURCE PURCHASING EXCEPTION PURSUANT TO SECTION 2-797(1) OF THE CODE OF ORDINANCES, FOR THE PURCHASE OF ENVIRONMENTAL SYSTEMS RESEARCH INSTITUTE (ESRI) ARCGIS MAPPING SOFTWARE LICENSES FOR THE CITY OF KEY WEST PLANNING DEPARTMENT IN A TOTAL AMOUNT NOT TO EXCEED \$29,950.00; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

WHEREAS, City staff recommends the sole-source purchase of ArcGIS Mapping Software Licenses for the Key West Planning Department, as they are the industry standard used by local agencies including Monroe County, Keys Energy, FKAA, Monroe County Property Appraiser, and the private sector; and

WHEREAS, the City Manager finds that pursuant to section 2-797(1), it is in the best interest of the City to authorize a sole-source expenditure for the ESRI ArcGIS software licenses and support, for a term of one-year with up to two one-year renewals,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the expenditure of funds not to exceed \$29,950.00, for the FY 14/15, and up to two one-year renewals at \$29,950.00 to Environmental Services Research Institute, Inc. is hereby approved on a sole source basis, pursuant to section 2-797(1) of the Code of ordinances.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
