		<p>On 09/12/2013, at approximately 1339 hours, the Key West Police Department Special Investigations Unit had an original active warrant for a Bobby Eugene Mosby reference the sale of cocaine within 1000 ft. of a church (Case # 13-3779), which was signed by the Honorable Judge Tegan Slaton on 09/12/2013, with a bond of \$25,000. We located Mosby, riding his bike west on the 600 block of Eaton Street. We exited our unmarked police vehicle and made contact with Mosby. Detective Siracuse handcuffed (double locked) Mosby and placed Mosby under arrest for the active warrant.</p>	
		<p>Search incident to arrest, Detective Siracuse found a clear plastic baggie containing multiple white rock like substances of suspected crack cocaine in Mosby's underwear. Detective Smith found three white rock like substances of suspected crack cocaine on the ground where we made contact with Mosby. Detective Smith field tested the suspected crack cocaine and it field tested positive for crack cocaine.</p>	
		<p>The amount of FTP crack cocaine is not consistent with personal use.</p>	
		<p>The amount of FTP crack cocaine (3.0 grams) is consistent with street level narcotic sales. I found \$420.00 of US currency in Mosby's right pants pocket in denominations consistent with street level narcotic sales.</p>	
		<p>Based on the facts and evidence there is probable cause to believe that on 09/12/2013, Bobby Eugene Mosby did knowingly and intentionally possess FTP crack cocaine with the intent to sell that FTP crack cocaine violating FSS 893.13 (1)(a)(1).</p>

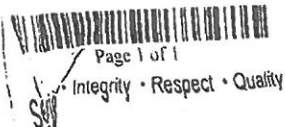
