- ▶ Staff has been actively participating in the Signage Taskforce and HARC/FIRM Taskforce.
- ▶ Staff has actively participated in Ambassadors' classes and Development Review Committee meetings as well as in staff meetings for capital projects such as Glynn Archer and Truman Waterfront.
- ▶ Just one Certificate of Appropriateness appealed in front of the Special Magistrate.

# Certificate of Appropriateness Review Statistics

- ▶ In 2013-14 Fiscal Year Staff approved **2,035** Certificates of Appropriateness or **92%** of received applications.
- ▶ During the Fiscal Year HARC held **15** public meetings. Staff prepared reports and packets for all public meetings.
- ▶ During 2013-14 Fiscal Year the Commission reviewed **109** applications, 73 of those applications were approved and 7 were denied, **27** were withdrawn or postponed.
- ▶ During 2013-14 Fiscal Year there was an increase in Certificates of Appropriateness if compare to 2012-13 Fiscal Year (**230 more applications**).

# Certificate of Appropriateness Review Statistics

- ▶ 9,214 Certificate of Appropriateness have been received and reviewed either by staff or the Commission in the past 5 years! Of those 95 applications, or 1.03%, were denied.

# Goals for 2015

- ▶ Draft New Ordinance and Guidelines for signage.
- ▶ Changes to the Historic Preservation Element of the City's Comprehensive Plan.
- ▶ Changes to the Historic Architectural Guidelines. Include guidelines for cbs structures, commercial, mix use and re adapted buildings. Include graphics for a more user friendly document.
- ▶ Draft Ordinance for preventing demolition by neglect.
- ▶ Prevent all loopholes between approved construction plans and HARC approved plans.
