An application was received for the removal of **(1) Mahogany tree**. A site inspection was done on February 11, 2015 and documented the following:

Tree Species: Mahogany (Swietenia mahagoni)



Mahogany tree







Diameter: 5.4"

Location: 40% (planted too close to building, adjacent to walkway-wrong tree, wrong place)

Species: 100% (on protected tree list)

Condition: 70%

Total Average Value = 70%

Value x Diameter = **3.7 replacement caliper inches**

Recommendations: Recommend approval of the removal of (1) Mahogany tree located at 94 Golf Club Drive, to be replaced with 3.7 caliper inches of FL#1 native dicot or fruit trees.
