In the event of any conflict between the terms contained in the Easement and this Amendment, the terms of this Amendment shall control.
- 4. <u>Interpretation</u>. This Amendment shall be interpreted as though each party contributed equally to its contents.
- 5. <u>Entire Agreement</u>. This Amendment and the Easement, and any exhibits to either, constitute the entire agreement between the parties hereto, and there are no other agreements or understandings relative to the transaction evidenced by such instruments not contained in this Amendment and the Easement.
