TO 11:50 P.M; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 10:00 A.M. TO 10:30 P.M; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

SECTION 1. That Mel Fisher Days, Inc. is hereby granted permission to conduct an Anniversary Celebration of the finding of the Atocha on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager; and that 25 % of gross revenue or \$1,000.00, whichever is more, shall be donated to the Wesley House Family Services, Inc..

SECTION 2. That Mel Fisher Days, Inc. is hereby granted permission for the closure of the 100 & 200 block of Duval Street from Greene to Eaton Street and Caroline Street from

Telegraph Lane to Ann Street on the date and during the hours stated above.

SECTION 3. That Mel Fisher Days, Inc. is granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinances, Mel Fisher Days, Inc is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.
