An application was received for the removal **of (1) Gumbo Limbo tree**. A site inspection was done on March 24, 2015 and documented the following:

Tree Species: Gumbo Limbo (*Bursera simaruba*)









Diameter: 12"

Location: 60%

Species: 100% (on protected tree list)

Condition: 30% (poor-canopy has been previously hacked)

Total Average Value = 63%

Value x Diameter = 7.5 replacement caliper inches

Recommendations: Recommend approval of the removal of (1) Gumbo Limb tree located at 715 Ashe Street, to be replaced with 7.5 caliper inches of FL#1 native dicot or fruit trees, on-site.

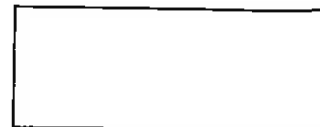
