

If the work is being done on or near a navigable waterway, **INDIVIDUAL/FIRM's** Workers' Compensation policy shall be endorsed to provide **USL&H** Act (WC 00 01 06 A) and **Jones** Act (WC 00 02 01 A) coverage if specified by the City of Key West. **INDIVIDUAL/FIRM** shall provide the City of Key West with a Certificate of Insurance verifying compliance with the workman's compensation coverage as set forth herein and shall provide as often as required by the City of Key West such certification which shall also show the insurance company, policy number, effective and expiration date, and the limits of workman's compensation coverage under each policy.



### 1. Information Page

#### Project Understanding

### 3. Methodology and Approach





Through a series of interactive workshops, we worked with the County's finance and public utilities staff in the development of a **customized financial planning model** to determine current and future sewer and stormwater rate revenue requirements. The results of the financial model were used in the subsequent cost-of-service analysis, rate design and connection fee study. Upon completion of the study, we provided staff training for continued use of the model. Our team also reviewed the County's ordinances and provided suggested language for

ARCADIS' interactive financial planning model was instrumental in assisting the County's Department of Public Utilities achieve a sound financial management plan. Historically, the department received an annual subsidy in excess of \$1 million from the general fund. The county used our financial model to develop a five-year plan not only to eliminate the annual subsidy but also to begin to repay the subsidization amount.

- Establishment of a fair and equitable rate structure that produces sufficient revenues to meet the utility's revenue requirements
- Maintain the utility's AAA bond rating and improve revenue stability
- Address customer affordability
- Maintain a pricing structure that encourages water conservation
- Implement a public involvement process to obtain feedback regarding the rate structure from customers served by the utility

ARCADIS developed a financial model to be used as a planning tool for establishing a financial plan and identifying future revenue requirements. Water and sewer cost-of-service studies were completed to identify the cost responsibility of various customer classes and to examine intra-class rate equity. An affordability analysis was completed to assess the impact of rate structure changes on low-income customers. A rate and fee survey was completed to compare Charlotte Water's rates with those of other water and sewer utilities in the Southeast and nationally.

The rate structure alternatives then were presented to the Restructuring Government Committee of the Charlotte City Council for consideration and approval.

This study highlights the importance of collaborative stakeholder involvement as part of a comprehensive rate evaluation that absorbs the public's concerns regarding the rate structure, thereby developing a rate structure that is best fitted for the community, improves the utility's public image, and improves the community's understanding and acceptance of the rate structure.

### 3. Methodology and Approach



#### **Example Solid Waste Rate Structure Design Considerations**





### Indirect Cost Study

#### Solid Waste Rate Structure Assessment

ARCADIS completed a solid waste rate study for the

Collier County Solid Waste Management Department. The primary objective was to establish a rate structure for solid waste services based on full cost accounting in accordance with requirements of the Florida Department of Environmental Protection. The project included the following tasks:

- Setting tipping fees for residential municipal solid waste (MSW), commercial MSW, yard waste and construction and demolition (C&D) debris at the Naples and Immokalee Landfills to appropriately reflect the true and full cost of providing the disposal service
- Setting the solid waste collection fees, rates and charges to residential and commercial customers to allocate the costs between these sectors, reflecting the true and full cost of providing transfer and collection service to each sector

- Developing a financial model that allocates the direct and indirect and fixed and variable costs to the different solid waste activities and billing categories, so that the true costs of providing a service are identified and a sensitivity analysis can be run to assess how changes to the system will impact future rates and charges
- Assessing the financial feasibility of implementing a variable rate billing system for residential waste services
- Completing a benchmark analysis to evaluate the impact of increasing the disposal fees charged at the Naples Landfill for construction and demolition debris, yard waste, used tires and white goods
- Assessing the adequacy of the landfill closure reserve fund

Energy (WTE) North County Resource Recovery Facility (NCRRF) for more than 17 years. We have acted on behalf of the Authority as Consulting Engineer, conducting quarterly and annual inspections and reporting findings on the performance of the private operator's operation. In this role, ARCADIS also assisted the Authority in negotiation of a 20-year extension of the private operator's operation and maintenance agreement and managed a \$200 million life extension and refurbishment project. As part of this effort, we conducted a rate and project feasibility analysis in support of rate making and bond financing. The refurbishment project was successfully completed in the fall of 2011.

For the last seven years, ARCADIS has assisted the Authority in development of a new 3,000-tpd mass burn WTE in order to meet the growing disposal needs of Palm Beach County residents. This is the first new WTE to be developed in the U.S. in more than 19 years. With the existing WTE, the new facility will provide the Authority with 5,000 tons of daily capacity and 150-MW of renewable energy. The project is being implemented utilizing a full service design-build-operate approach. Berkley County Water and Sanitation (BCWS) provides County-wide recycling and solid waste disposal services. The

facilities owned and operated by BCWS include a Class Three Landfill, Class Two Landfill, a Class One Landfill, two Closed Landfills, nine Residential Convenience Centers and several satellite Recycling Facilities. Rates for solid waste services including the per-ton tipping fee for municipal solid waste (MSW) and annual assessment on residential and commercial properties for solid waste services have not been changed since 2004. Over the past 10 years, the services provided, the means and methods of providing services and the cost of providing those services have changed.

ARCADIS completed a **comprehensive solid waste rate study** for BCWS to ensure that the solid waste rate structure is equitable, adequate and reliable for recovery of costs and establishment of prudent reserves. Our approach included development of a financial planning model to determine annual rate revenue requirements, a cost of service analysis to determine the true and full cost of providing recycling and disposal services, an evaluation the current rate structure as compared to a "Pay-As-You-Throw" (PAYT) rate structure, and the provision of recommendations based on the study findings.

ARCADIS developed an interactive, multi-year financial planning model based on the most current budget information taking into account operational expenses, equipment replacement plans, capital improvement requirements, debt service payments, renovation and replacement account funding, shared services and overhead cost allocations to be provided by BCWS. We analyzed the fixed costs, variable costs, current tipping fees, and costs related to environmental controls/compliance to calculate the cost of service for residential MSW, commercial MSW, yard waste, special wastes and construction and demolition (C&D). As part of this effort, the following was also considered:

- The statutory limits of reserve funds
- The cost of closure at the current operating landfills
- The cost of long-term care for the closed landfills
- The currently established or desire to establish various funds to address potential issues such as a capital recovery fund to finance future solid waste projects as

landfill capacity is depleted or emergency response recovery funds to cover non-eligible costs and initial mobilization capital.

Upon identification of the cost components, recommended disposal tipping fees for residential units, commercial containers, landfill gate rate for MSW, mixed waste (non-MSW), C&D, special wastes and biomass were calculated. The model projected suggested tipping fees for the next five years, and provided estimated tipping fees for an additional 15 years, for a total planning horizon of 20 years.

Evaluate PAYT Program. ARCADIS also compared a Save Money and Reduce Trash (SMART) program, also known as a PAYT program to the current solid waste rate structure. Since BCWS does not provide County-wide collection services, the comparison of the SMART program focused on a bag and tag type programs versus a variable container size programs. ARCADIS provided an overview of the various types of SMART programs in use across the country and identifying program advantages and disadvantages specifically pertaining to BCWS. A comparison of the projected economics, taking into account the revenue and expense of implementing a bag and tag program including cost of administration of the program was compared to the current structure, and included assumptions regarding the anticipated impact on recyclable materials recovery and waste generation disposal quantities.

Potential barriers to implementing a SMART program rate structure were identified to allow BCWS to assess the potential technical and financial feasibility of implementing a bag and tag SMART program in their service area and allow the development of recommended next steps. The potential barriers and projected operating results were assessed, based on historic experience and current and anticipated solid waste management program and requirements.




