A RESOLUTION OF THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY (CRA) APPROVING AN EXEMPTION COMPETITIVE BID REQUIREMENTS FOR PROJECT #KB1205 - TURTLE KRAALS WALL REBUILD BY DN HIGGINS, INC., PURSUANT TO SECTION 2-797(4) OF THE CODE OF ORDINANCES, IN A TOTAL AMOUNT NOT TO EXCEED \$ 67,000.00; APPROVING A ALLOWANCE FOR UNFORESEEN CONDITIONS; AUTHORIZING NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, an invitation to bid (ITB #15-015) was properly advertised and scheduled to open on March 4, 2015, however no bids were received; and

WHEREAS, there is a need to rebuild the subject wall at Turtle Kraals, and CRA/City staff requested price quotes from three local vendors, with DN Higgins, Inc. submitting the lowest price quote; and

WHEREAS, Key West Code of Ordinances section 2-797(4)(b) provides "If in the opinion of the city manager exceptional circumstances exist to exempt a purchase from the competitive bid requirements of this subdivision for the best interests of the city, he shall place a resolution before the city commission for approval of such exemption."; and

WHEREAS, the Key West Bight Board recommended approval of the lowest price quote at its meeting of April 15, 2015;

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1: That an exemption to competitive bid requirements, and the expenditure of funds not to exceed \$67,000.00, to DN Higgins, Inc., for Project #KB1205 - Turtle Kraals Wall Rebuild, is hereby approved, pursuant to section 2-797(4) of the Code of ordinances.

Section 2: That a 10% allowance for unforeseen conditions is authorized.

Section 3: That a budget transfer from 405 Reserves Fund in the amount of \$25,665.00 to account #405-7504-575-6200 Project KB#1205 is hereby approved.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.
