An application was received for the removal of (3) Gumbo Limbos, (1) **Royal Poinciana**, (1) Mahogany, and (1) Unidentified tree. A site inspection was done on April 27, 2015 and documented the following:

1. Gumbo Limbo (Bursea simaruba)



Diameter: 2.5" Location: 60% (on fence line) Species: 100% (on protected tree list) Condition: 60% Total Average Value = 73% Value x Diameter = 1.8 replacement caliper inches



Diameter: 10" (multi trunked) Location: 70% Species: 100% (on protected tree list) Condition: 60% Total Average Value = 76% Value x Diameter = 7.6 replacement caliper inches Recommendations: Recommend approval of the removal of (3) Gumbo Limbo, (1) Royal Poinciana, (1) Mahogany, and (1) Unidentified tree located at 1109 Fleming Street, to be replaced with 34.1 caliper inches of FL#1 trees from approved list.


