A RESOLUTION OF THE NAVAL PROPERTIES  
LOCAL REDEVELOPMENT AUTHORITY OF THE CITY  
OF KEY WEST (LRA) APPROVING AMENDMENT NO.  
1 TO TASK ORDER No. 2, FOR TRUMAN  
WATERFRONT DESIGN SERVICES, UNDER THE  
"AGREEMENT BETWEEN CITY OF KEY WEST NAVAL  
PROPERTIES LOCAL REDEVELOPMENT AUTHORITY  
AND BERMELLO AJAMIL AND PARTNERS, INC.  
FOR PROFESSIONAL LANDSCAPE  
ARCHITECTURAL/ENGINEERING/ARCHITECTURAL  
/LAND SURVEYOR SERVICES FOR TRUMAN  
WATERFRONT UPLAND DESIGN AND  
CONSTRUCTION ADMINISTRATION" IN AN  
AMOUNT NOT TO EXCEED \$23,300.00;  
PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 11-327, the LRA awarded a  
contract to Bermello Ajamil and Partners, Inc. for services  
related to the Truman Waterfront Upland Design and  
Construction Administration, and in Resolution 12-065  
awarded Task Order No. 1, and in Resolution 14-095 awarded  
Task Order No. 2; and

WHEREAS, State code compliance requires restrooms for  
an interactive water feature which is included in Phase 1 of  
the project development;

NOW, THEREFORE, BE IT RESOLVED BY THE NAVAL PROPERTIES  
LOCAL REDEVELOPMENT AUTHORITY, AS FOLLOWS:

Section 1: That Amendment #1 to Task Order No. 2  
for Design Services under the "Agreement Between City of Key  
West Naval Properties Local Redevelopment Authority and  
Bermello Ajamil and Partners, Inc. Professional Landscape  
Architectural/Engineering/Architectural/Land Surveyor  
Services for Truman Waterfront Upland Design and  
Construction Administration" is hereby approved in an amount  
not to exceed \$23,300.00.

Section 2: That this Resolution shall go into  
effect immediately upon its passage and adoption and  
authentication by the signature of the presiding officer and  
the Clerk of the Authority.
