## RE: Closure of an Old Permit, 1002 Washington Street



On January 26, 2012, a permit was issued (T12-5899) for the removal of 1-Coconut Palm at 1002 Washington Street. On May 6, 2015, a site inspection documented that a fiddlewood tree had been planted on the property as a replacement.


The above open tree permit requires the replacement of 1 native palm onto the property. The property owner planted the fiddlewood instead of a palm because there were already a lot of palms on her property. She is requesting closure of the old palm permit.

The Tree Ordinance allows for the Tree Commission to approve the request of the replacement changes from palm to dicot trees and visa versa. In evaluating the request, if the homeowner had paid a fee for the palm into the tree fund, she would have had to pay \$250 (\$250 x 1 palm tree). That amount is equivalent to 1.6 caliper inches of dicot trees if a fee was paid (\$250/\$150 per inch). The total caliper inches of the fiddlewood tree that was planted on the property is approximately 3.5 caliper inches.

Therefore, the Urban Forester recommends approval of the closure of tree commission permit T12-5899.

In lieu of planting tree(s), you may choose to pay mitigation fees to the City Tree Fund, please make your check payable to "City of Key West" and make reference to number **00100003660100** on your check. Mitigation fees are as follows: \$250 per tree for palm trees, and/or \$150 per required replacement caliper inch for dicot/canopy or fruit trees.
