
An application was received for the removal **of (1) Woman's Tongue tree**. A site inspection was done on May 21, 2015 and documented the following:


Tree Species: Woman's Tongue (Albizia lebbeck)


















Diameter: 33" - 24" = 9.7" (tree regulated because of diameter > 24")

Location: 40% (foundation issues on two properties)

Species: 0% (on not protected tree list)

Condition: 50% (fair to poor-poor structure, decay)

Total Average Value = 30%

Value x Diameter = 2.9 replacement caliper inches

Recommendations: Recommend approval of the removal of (1) Woman's Tongue tree located at 2210 Patterson Street, to be replaced with 2.9 caliper inches of FL#1 native dicot or fruit trees to be planted on site.
