ITEM 1 – SCOPE OF SERVICES

Our professional engineering services shall consist of the following:

Data Collection/Survey

- 1. Perform project area inspection to confirm existing physical conditions pertaining to current stormwater drainage elements, patterns and characteristics.
- 2. Prepare a detailed topographic survey of the area.

Construction Drawings

- 1. Prepare a detailed Site/Geometry Plan for location of parking lot and site improvements including:
 - Edge of pavement signature indicating curb type, edge type, etc...with supporting details.

- Striping and Signage information with supporting details.
- Layout data, setbacks, buffers, etc...
- 2. Prepare Grading and Drainage Plans including proposed spot elevations for all drainage improvements. Provide all inverts, pipe sizes, pipe slopes, and other data relative to sub-surface conveyance systems.
- 3. Prepare a Site Lighting/Electrical Plan and appropriate details. This shall be prepared by a licensed Electrical Engineer and shall be coordinated with Keys Energy.
- 4. Prepare a Landscape Plan and appropriate details. This shall be prepared by a licensed Landscape Architect.
