

An application was received for the removal **of (1) Pink Tabebuia tree**. A site inspection was done on June 10, 2015 and documented the following:

Tree Species: Pink Tabebuia (Tabebuia heterophylla)











Diameter: 37'' - 24'' = 13''

Location: 50% (tree actually located along Canfield Lane in rear of

property)

Species: 0% (on not protected tree list-regulated due to size)

Condition: 50% (fair to poor) Total Average Value = 33%

Value x Diameter = 4.2 replacement caliper inches

Note: There are actually two pink tabebuia trees. The larger tree's root system has taken over the smaller tree. The smaller tree is less than 24" diameter (no permit required for removal).

Recommend approval of the removal of (1) Pink Tabebuia tree at 622 Grinnell Street to be replaced with 4.2 caliper inches of FL#1 dicot trees from approved list.


